TNC Study

- Study began January 2014
- Collected input from broad range of stakeholders
- Goal was to establish framework that would:
 - Ensure safety of passengers, drivers and public
 - Provide transportation options
 - Support new technology solutions
 - Attract new businesses to the Commonwealth

Committee Structure

Licensing of TNCs

Requirements:

- File application
- Pay \$25,000 performance bond
- Demonstrate compliance with insurance requirements
- Complete fitness exam
- Pay fees



Licensing of TNCs

- New TNC application, TNC certificate, TNC manual
- Application and accompanying documents sent to TNCs currently operating in VA
- Insurance form to be filled out by respective insurance companies under review
- Notice to insurance companies about new TNC law and provisions/forms/filing



Registration of TNC Vehicles

- Virginia and out-of state registered vehicles must register for "TNC Use"
- Vehicle owner or driver may register the vehicle
- TNC may register the vehicle for their driver
- If working for more than one TNC, only need to register the vehicle once
- Begin transitioning current vehicles June 4



Registration of TNC Vehicles

Service Channels

- Customer service centers, web, mobile web, mail, fax
- Limited transactions by DMV Select
- TNC can register vehicles through a secure portal
- Two new TNC application forms



Vehicles Registered in Virginia

- Driver is owner/lessee Most service channels can be used and credentials will be issued directly to driver
- Driver is not the owner/lessee
 - ➤ Have owner's signature driver will receive credentials
 - Certify owner's consent transaction is processed, VCIN is updated, credentials are mailed to the owner, driver has 30 days to display decals

Vehicles Registered Out-Of-State

- Must be registered by the owner or lessee
- Register by mail, fax or electronic submittal
- All are processed by Motor Carrier Services
- TNC record created in the DMV system
- Working on display of information in VCIN
- Owner/lessee mailed credentials




Out-of-State Window Decal

Enforcement Program

Passenger carrier enforcement plan to ensure compliance with statutes includes:

- Requirements officers must check to confirm compliance with statutes
- Process for capturing and reporting all actions
- E-Learning and outreach to VSP, local enforcement
 & airports on new legislation
- Process to capture, investigate and track all complaints



Compliance Program

- Reviews to be conducted no more than once per year, and to respond to an incident or complaint
- Outlined specific requirements that DMV staff must verify to ensure TNC compliance with the new law
- Developing a process to electronically receive necessary documents from TNCs



Reports

- Quarterly Report requested by Senator Newman and Delegate Rust to capture enforcement activity (October - first report)
- December 2015 update report for General Assembly members
- December 2016 report enforcement activity, insurance changes, cost recovery
- Track impact on the disabled community

Communications Plan

Targeting Three Audiences:

- TNC Partners (Drivers)
 - Law Enforcement



Communication Channels:

- Brochures for TNC partners and law enforcement
- Statewide news releases
- Social media messaging for TNC partners and the general public
- Website content

Transition Plan

- Is onboarding process for partner and vehicle robust enough to comply with statutory requirements?
- TNCs currently operating under TOA must certify compliance with those requirements
- TNCs currently operating required to apply again and complete application requirements
- Certificate must be granted effective July 1 to continue operation
